☐ **New Patient Visit**

Time: 45-90 minutes per patient

- Establish care with Rees-Jones Center and with PCP
- Address urgent medical and behavioral health needs
- Medical exam (meets three-day visit requirement, if applicable)
- Blood work and other studies (if needed)

☐ **Well-Child Check (Texas Health Steps Visit)**

Time: 30-60 minutes per patient

- Texas Health Steps Physical
- Address or follow-up on medical, developmental and behavioral health needs
- Vaccines (if needed)
- Blood work and other studies (if needed)

☐ **Integrated Visit**

Time: 1-2 hours per patient

- The PCP and a member of the behavioral health team will establish the needs for behavioral health and/or make sure needs are being met through community services or resources
- Any medical needs will also be addressed at this visit, including a Well-Child Check/Texas Health Steps visit (if needed)

☐ **Follow-up Visit**

Time: 30-60 minutes per patient

- Continue to make sure medical and behavioral health needs are being met
- Can be medical visit only or integrated with behavioral health
- Offer any additional support and services (if needed)

Check list for adoption transition:

- ☐ Schedule pre-adoption and post-adoption visits
- ☐ Ensure all medications are refilled
- ☐ Decide on and change insurance
- ☐ Find new pediatrician and schedule first appointment. Child cannot be seen at the Rees-Jones Center for sick or other if greater than 30 days post adoption.
- ☐ Verify that therapy companies accept your insurance and know of insurance change
- ☐ Establish behavioral health provider and psychiatry as needed within your insurance network
