Construct	Item
Physical IPV (Threats and Acts)	How often (has/did) {initials} (threatened/threaten) you with violence, (pushed/push) or (shoved/shove) you, or (thrown/throw) something at you that could hurt?
Physical IPV (Acts)	How often (has/did) {initials} (slapped/slap), hit or (kicked/kick) you?
Sexual IPV	How often (has/did) {initials} (insisted/insist) on or (made/make) you have sexual relations with (him/her) when you didn't want to?
Physical Impact	How often (have/did) you (had/have) an injury, such as a sprain, bruise, or cut because of a fight with {initials}?
